2. This provisional affiliation is based upon the approval accorded to the institute by the AICTE vide F. No. Northern/1-44643402742/2025/EOA, 30/04/2025.
3. The grant of provisional affiliation is subject to attending to all the deficiencies/ shortcoming/advice/suggestions pointed out by the inspection team in its report dated 24/07/2025 (a copy attached). Please send compliance report through affidavit within a period of 03(Three) months to the University from the date of issue of this letter.
4. The University may inspect the College at any working day without information to check the infrastructure and other academic activities of the College as per guidelines of GoB/BEU.
5. All minutes of Governing Body of the College should be submitted to the office of the Bihar Engineering University, Patna at the earliest.
6. When any vacant posts will be filled by the College, University representation should be invited. Any appointments must be done in the presence of University Representative.
7. College is requested to approve and appoint all teaching & non-teaching employees as per guidelines of the AICTE in three months.
8. The provisional affiliation has been granted in anticipation of approval of the Executive Council, Bihar Engineering University, Patna.
9. Failing the above terms & conditions, this letter will be automatically treated as withdrawn. In such a case no further correspondence shall be entertained.
